

## Reduce AFE/LOE Where Possible



#### **<u>Completion AFEs reduced with the patented Sand Commander</u>**

- The patented Sand Commander was designed with maximum ESG benefits and compliance in mind
  - Improves HSE (safety) performance on location
  - Captures 99.9% of natural gas encountered during the drill out, allowing for optionality away from flaring

- Enhanced water filtration allowing for reduced freshwater usage; lowers emissions via lower water hauling/trucking activity
- Cloud based data acquisition for state reporting requirements and remote location monitoring
- Improved well planning & completion designs with institutional post job reporting
